Research conducted by (Astuti et al., 2021; Hanif, 2020; Puspaningtyas & Ulfa, 2020; Putri et al., 2022)

shows that the use of animated videos can improve student learning outcomes in science material. In this study, animated videos were used as learning media for science material that was difficult for students to understand. The results of this study indicate that students who use animated videos in learning have better learning outcomes compared to students who do not use animated videos.

The use of e-books in learning

Research conducted (Aswirna & Ritonga, 2020; Dewi & Agung, 2021; Tang, 2021) shows that the use of e-books can improve student learning outcomes in history subjects. In this study, e-books are used as learning media which contain historical materials that are presented interactively. The results of this study indicate that students who use e-books in learning have better learning outcomes compared to students who do not use e-books.

The use of internet media in learning

Research conducted by (Arisanti & Subhan, 2018; Pibriana & Ricoida, 2017; Rizalia et al., 2022; Yani, 2019) shows that the use of internet media can increase interest in learning and student learning outcomes. In this study, internet media is used as a learning medium which contains interactive mathematical materials. The results of this study indicate that students who use internet media in learning have a higher interest in learning and better learning outcomes compared to students who do not use internet media.

The use of games in learning

Research conducted by (Deta et al., 2021; Syawaluddin et al., 2020; Yu et al., 2021) shows that the use of games in learning can improve student learning outcomes in social studies material. In this study, games were used as learning media for social studies material that was difficult for students to understand. The results of this study indicate that students who use games in learning have better learning outcomes compared to students who do not use games. In these studies, the use of multimedia and internet media can improve student learning outcomes. This is because the use of multimedia and internet media can help students understand the material in a more interesting and interactive way. In addition, the use of multimedia and internet media can also motivate students to learn because of the different and interesting ways of delivering material.

The use of multimedia facilities and internet media in learning also has several weaknesses. One of them is the possibility of student dependence on the media. Research by Arifin & Rahmadi (2017), found that gadget addiction behavior can affect student achievement. Technical problems such as limited internet access or device damage can also be an obstacle in the use of multimedia technology and internet media in learning. This can disrupt the teaching and learning process and reduce the effectiveness of the media. Research by Jayawardana (2017) shows that the quality of internet signals and the availability of adequate multimedia devices are very important in using internet media as a learning tool.

In addition to student dependency and technical constraints, the use of multimedia technology and internet media also requires special skills for teachers in managing and presenting learning materials properly. Teachers need to master multimedia technology and internet media well in order to be able to select, develop and manage learning content according to the characteristics of students. Research by Putrisari (2022) found that teachers who have the ability and skills to use multimedia technology and internet media can improve student learning outcomes.

Even though it has several weaknesses, the use of multimedia technology and internet media still has a positive impact on the learning process. The use of internet media as a learning tool in elementary schools gives positive results to students' understanding of the material being taught. Therefore, the use of multimedia technology and internet media needs to be well integrated in learning to increase the effectiveness and efficiency of the teaching and learning process.
